In tandem, we have continued to provide essential data to law enforcement and federal agencies, reinforcing the importance of our collaborative efforts. SoS Highlights





Highlight 1: Data
Information Provided

Over the past year, Shadows of Strength (SoS) has continued to make significant strides in the fight against human trafficking across the tricounty region of Escambia, Okaloosa, and Santa Rosa County, Florida. Building upon the foundation laid in the previous year, our diligent information gathering efforts—supported by over 3,000 hours of dedicated volunteer work—have allowed us to expand our understanding of the complex networks operating in our communities. This year, we successfully identified from the information in 2024: 11 additional human trafficking victims, 9 additional human traffickers, 1 recruiter, and 3 bottoms, further illuminating the pervasive issues we face.

One of the most compelling aspects of this year's progress has been the successful outreach to Survivors in need. We had two Survivors reach out for assistance in a particularly urgent situation: a victim had been transported from Alabama to Mississippi and was on the way to Los Angeles. Drawing upon our network and resources, we were able to coordinate efforts to ensure that the victim was safely returned to Pensacola. This situation highlights the importance of our work and the trust that Survivors place in us. It underscores our commitment to providing immediate support and intervention for those trapped in these dire circumstances.

- 1. Hygiene Bags: This year, we successfully donated 15 book bags filled with essential hygiene products, distributing 6 to local law enforcement and 5 directly to Survivors in need. As we continue this initiative, we are actively seeking additional book bags to further enhance our outreach and provide critical support to those impacted by human trafficking.
- 2. Legislative Changes: In collaboration with Retired Lt. Col Carmen Reynolds, we are advocating for important changes in Florida's legislation surrounding rideshares and human trafficking. Our proposed bill, informed by real cases handled by Shadows of Strength, aims to address this grave issue and enhance protections for vulnerable individuals in our communities.
- 3. Human Trafficking Courts: We have formed a dedicated team, including members from the University of West Florida's Criminal Justice Department and the Friends of Santa Rosa County Veterans Treatment Court, to establish Human Trafficking Courts. Listening to the voices of our clients has underscored the necessity for this initiative, and we are proud to have a local survivor contributing her insights to ensure that her experiences help shape a more compassionate and effective judicial response.
- 4. Law Enforcement Training: We are excited to announce the development of our first-ever law enforcement training program, aimed at equipping officers with the knowledge to understand how human trafficking networks operate and identify related crimes. At Shadows of Strength, we emphasize that our clients' choices are paramount; we do not compel them to testify or report, but instead provide them with the information and support they need to feel believed and empowered in their journey toward justice.

She highlighted the intricate web of these networks and the urgent need for strategic community involvement and law enforcement collaboration to disrupt their operations.

Her insights not only brought necessary attention to this pressing matter but also reinforced our commitment to combat human trafficking and support affected communities through targeted initiatives and advocacy efforts.

Looking Ahead



As Shadows of Strength enters the year June 2025 to June 2026, we are preparing for another impactful year of information gathering and strengthening trust between victims, survivors, and law enforcement. We recognize that building these foundational relationships is crucial in the fight against human trafficking. The following are a few of the additional initiatives we will be working on:

- 1. **Establish Emergency Protection Protocols:** Develop and implement comprehensive emergency protection and safety protocols for victims of human trafficking that become standard practice across Northwest Florida. This includes training sessions for local law enforcement, healthcare providers, and community organizations to ensure awareness and adherence to these protocols.
- 2. **Launch a Human Trafficking Court:** Continuation of our collaboration with local Survivors, local stakeholders, including the University of West Florida Criminal Justice Department and legal experts, to finalize and launch the human trafficking court. This goal includes the establishment of legal frameworks, support services for survivors, and ongoing training for court personnel to ensure sensitivity and effectiveness in handling cases.
- 3. Advocate for Ride Share Legislative Changes: Successfully navigate the legislative process to introduce and pass the drafted bill SoS has created to enhance protections against human trafficking and sexual assault within ride-sharing services in Florida. This will involve building coalitions with advocacy groups, stakeholders in the transportation industry, and policymakers to garner support for the bill.
- 4. Advocate for Legal Reforms on Felony Backgrounds: Work towards enhancing legal frameworks that address the accountability of individuals with felony backgrounds who commit illegal acts or provide illegal items, such as firearms or drugs, that result in the harm or murder of victims. This goal will involve collaborating with lawmakers, legal experts, and advocacy groups to propose reforms that increase penalties and improve prosecution strategies for those who facilitate violence against vulnerable populations, thereby contributing to overall community safety and justice.
- 5. **Implement Human Trafficking Awareness Initiative:** Organize and launch SoS's first human trafficking awareness initiative in Northwest Florida, focusing on educating the community about the local dynamics of human trafficking operations. This initiative will include workshops, public seminars, and distribution of informational materials, aiming to engage community members and encourage proactive involvement in prevention efforts.

We are committed to making tangible contributions that not only combat human trafficking but also offer healing and hope to those who have served our nation, creating a comprehensive support network for all those affected.
